



END USER LICENSE AGREEMENT

This End User License Agreement ("Agreement") governs your download and installation of, and access to and use of, the virtual reality application (the "Licensed Application") that is provided by Codemodeon Bilisim Cozumleri ve Ticaret Ltd Sti ("Codemodeon").
